ANNUAL REPORT

1954 - 1955



The ensuing pages record the work of the Council in the past year; it does not purport to be an exhaustive or comprehensive report, for to the important work of the nine Rural Community Councils and Local Councils of Social Service, there can be but passing reference. The Council only sets out its own record of activities over a wide and diverse field.

RURAL ACTIVITIES

On the 1st April, 1954, the Development Commissioners' new policy for the Rural Areas came into operation. Briefly the effect of the new policy was to consolidate the work of Rural Community Councils and to provide opportunities for new development.

The implementation of this new policy brings to the Council new opportunities and greater responsibility, both in the oversight of the work of Rural Community Councils and in the Council's own Rural department.

To meet these new conditions and to make their influence more effective, the Council established a Rural Committee. The functions of the Committee are to study conditions in Rural Wales, and possibly from time to time to make local surveys. It will concern itself mainly with:

(a) **Social and Recreational**

The erection of Village Halls.

The maintenance and use of these halls and the provision of Playing Fields.

(b) **Industrial**

A study of the various types of farming in Wales.

A survey of Rural Industries, and make, if possible, suggestions for their development, and also for the introduction of new industries, with special reference to industries ancillary to agriculture and forestry.

(c) **Educational**

Music, Drama, Craftwork, and the encouragement of the formation of classes in these subjects.

The Committee will work in close association with the nine Rural Community Councils in Wales, and will make, through the officers of the Council, periodic reports on these activities.

In the Counties where a Rural Community Council has not been established—Flintshire, Radnorshire, Breconshire and Glamorgan, the Council's Rural Department acts as the Rural Community Council, and the following details apply to those Counties only.

VILLAGE HALLS

Last year we reported "That the grant conditions imposed by the Ministry of Education have a serious effect on building developments." This year we are happy to report that conditions have been eased very considerably and in consequence of this easement, there has been, as the following table indicates, considerable revival of interest and activity among Village Hall Committees.

- (a) Seven Village Hall Schemes have already been submitted to the Ministry for grant-in-aid.
- (b) Six schemes are in course of preparation for submission to the Ministry.
- (c) Seven schemes are in the initial stage of development.

Temporary Village Halls are in course of construction at Gilwern and Cwmdu, Breconshire.

PLAYING FIELDS

The Council provides the secretariat for four County Playing Fields Associations. This has involved the stimulation of interest in the provision of Playing Fields and rendering of all possible advice and assistance to Local Authorities and Voluntary Organisations in their schemes to provide such amenities.

Twenty-three schemes were assisted by the Council's Rural Officer, and received grant-aid from the National Playing Fields Association during the year. Six other schemes are in various stages of development. The spread is interesting, as it includes Flintshire, Radnorshire, Breconshire and Glamorgan.

Over and above these services, the Council encourages local Village Committees, formed with the object of obtaining either a Village Hall or Playing Field, to extend their activities to include all the interests of village life, to consider the welfare of the village as a whole, and to provide undertakings which are generally desired and which will succeed better by teamwork. This association of village interests with the Village Hall or Playing Field is essential to the maintenance of a lively and dynamic Village Community.

PARISH COUNCILS

There is an encouraging and genuine realisation of the part that Parish Councils can play in Local Government structure. There is no problem affecting the dwellers of the Rural Areas which has not been tackled by the different County Associations of Parish Councils and brought to the notice of the higher authorities concerned, often with a considerable measure of success. Questions of telephone facilities, better and more frequent bus services, water supplies, lighting, Playing Fields, rights of way—all these and many more have been discussed and followed by action. Another valuable service performed by the County Association is to act as an information bureau for the individual Parish Councils and to assist them with advice upon their many

problems. A further important activity is that of propaganda and education, and many Area Committees hold lectures and schools on various aspects of Local Government.

The National Parks and Access to the Countryside Act came into force in 1949. Every County Council in England and Wales was required to "survey rights of way" in their administrative area, and to prepare and draft maps and statements. The Act provided that County Councils could delegate this duty to Parish and District Councils. It is pleasing to find that in Wales, County Councils invited Parish Councils and District Councils to undertake this work. This has been a formidable task, and we are happy to report that eleven of the thirteen Counties of Wales have completed the survey and prepared maps and statements.

At a time when the tendency is towards centralisation and larger administrative units, the Parish Councils remains the Citadel of local effort and voluntary endeavour, and the unit of democracy in the countryside.

"BRO"

In the course of the year the Council published a bilingual magazine, "Bro." This magazine dealt, in the main, with Welsh rural problems. We are grateful to those who wrote for this magazine, which was well received.

CLUBS AND CLUB GROUPS WOMEN'S CLUBS

We are happy to report further improvement in the development of Women's Clubs during the year. Three new Clubs have been formed, making a total of 120 Clubs with a membership of over four thousand.

All Clubs receive regular instruction in Handicrafts, Homecraft, and kindred subjects. Many of the Club members are keen choristers, while others interest themselves in dramatic activities.

The following table of instructional sessions indicates the measure of their activity :

Interest in these basic subjects was further stimulated by the holding of forty-six day schools in Dressmaking, Eiderdown making, General Handicrafts, Cake-icing, Poultry Trussing, Flower Decoration and Drama. All these subjects have their devotees, and it is generally true that the more practical the craft, the more popular it is.

Dramatic production becomes increasingly popular and there was keen competition for the honour of staging one-act plays at the Annual Festival. Nine companies were selected for the final competition to compete for the

Council's Challenge Shield. There was a noticeable improvement in production and individual performance. Final place was awarded to Taff Street No. 1 Club, Pontypridd.

A highly successful Eisteddfod was held, when all Club activities were represented; the Challenge Cup being awarded to the Club obtaining the greatest number of points. The competition was keen and close, the successful Club being Gowerton, with Bryntirion and Capel Dewi being close runners up.

MEN'S CLUBS

While activities vary in interest and intensity from Club to Club, Woodwork, Upholstery, and Weaving are the main interests. Instruction is also available in Lino cutting, Book-binding, Wood-carving and Physical Training.

The following table of instructional visits is indicative of the part that occupational activity plays in Club programmes :

Some of our Clubs are developing into what are practically small Community Centres, and are serving a useful purpose in areas where their buildings are the only ones available for the use of the general public. One of the secrets of the success of the Clubs is that they are keenly interested in the life of the community and are prepared to do what they can to meet its needs.

DRAMA

During the year under review, the Council has carried out an intensive programme for the encouragement and development of Amateur Drama in Wales. Early in the year the Council convened a Conference of representatives of County Drama Committees, Secretaries of Rural Community Councils and individuals interested in amateur drama.

The Council's officers explained that the object of the meeting was to form a Drama Association for Wales, the Council's constitution made it competent to set up such an Association and to deal with amateur drama on a national basis. After discussion the Conference unanimously resolved to form a "Drama Council for Wales" and that the Headquarters shall be at the offices of the Council of Social Service for Wales and Monmouthshire.

The Drama Council has for its main objects :

- (1) The promotion and organisation of one-act play competitions on a National and Regional basis.
- (2) The encouragement of play-writing in the Welsh and English language.
- (3) The organisation of Drama Schools.
- (4) The promotion of the organisation of the examination of the Amateur Drama Board.

The Drama Library.—The Council provides a comprehensive service for the whole of Wales. It has an extensive drama library containing over ten thousand copies of plays and text books which are available on loan to all Amateur Societies and students of Drama throughout the Principality. Competent advice on the selection of plays is readily given by the officer in charge. During the year 1954/55, 899 sets of plays, and 2,254 single copies were borrowed. Heavy demands were made upon our stage curtains and lighting equipment. Stage curtains were borrowed by 86 Drama Societies and lighting equipment by 47 Societies.

Under the Council's Drama Advisory service, 92 advisory visits were made by members of the Council's panel of advisers. Lectures were given on Production, Speech, Mime, Movement, Grouping, the production of Passion Plays and the formation of Drama Groups.

Six one-day schools and a one week residential school were held during the year. These events were highly successful and the work of those who attended received high praise from the Tutors.

The Council—for the second year, in co-operation with the Drama Leagues of Glamorgan and Monmouthshire—organised a course of lectures and demonstrations to prepare students for the examination of the Amateur Drama Board. Twelve students attended the course and presented themselves for examination: of this number five candidates were successful and were awarded the "Amateur Drama Board Diploma."

COMMUNITY CENTRES AND ASSOCIATIONS

The range of the Council's activities in this field may be inferred from the following statistical summary of the position at the end of the period under review:

Bare statistics cannot give a true picture of the immense efforts made by many voluntary groups of people to secure adequate facilities for physical, social and educational activity in their respective neighbourhoods. The fruition of such efforts was delayed during the past year by the restrictions relating to grants and buildings. At the close of the year, however, the Government's decision to relax these restrictions gave new hope and stimulus to a large number of projects. It is stated that priority in grant-aid will be given to urgent schemes; but then we all believe that the needs in our neighbourhood are greater than elsewhere. Community Associations, without premises, are everywhere preparing schemes, and even if all cannot be successful in their applications, it is important that these schemes should be presented, so that the Ministry of Education might know the extent of the demand.

For several good reasons, the new housing estates continue to claim first attention. In this connection, two salient points call for consideration : (1) Where it is proposed to erect a Centre by voluntary labour, and thus qualify for a higher proportion of grant, careful planning and marshalling of that labour is essential ; otherwise, the project may come to a halt before completion. This is the case in one neighbourhood at present, and it is difficult to rekindle the necessary interest to finish the work. (2) It is all too easy to assume that a community spirit can be created merely by bringing people together in large groups for social occasions. While such occasions have their undoubted value, people in fact find more lasting satisfaction in smaller groups which cater for special interests. The more vital, if difficult, task of the Community Association, is to relate the enthusiasm and leadership of these groups to the wider service of the neighbourhood.

CITIZENS' ADVICE BUREAUX AND SOCIAL WELFARE

The Council at its own office provides a service of information and advice. During the period October, 1954—March, 1955, this has become more widely known and there has been a marked increase in the number and variety of problems, and enquiries dealt with by the officer. Our assistance is sought by letter and telephone from all parts of the country and also from overseas. Insofar as possible it has been ensured that all enquirers, personal and otherwise, seeking help or advice have received the necessary aid or been guided to the source where it could be obtained.

Co-operation with other Organisations.—Assistance has been given to other Citizens' Advice Bureaux; Local Government Organisations; Local Voluntary Organisations; Family Welfare Association; Rural Community Councils; National Newspaper Advice Services; Overseas Welfare Services; Blind organisations; King Edward VII German Foundation, etc.

The Council's Officer, acting in an advisory capacity to Bureaux in Wales and as liaison officer between the Welsh Regional Services and the National Citizens' Advice Bureau Service is also a member of the National Citizens' Advice Bureaux Committee. Thus close contact is maintained with the Headquarters services.

An effective co-operation exists between the department and Statutory and Voluntary Bodies.

Situation Report.—Apart from the Central Service indicated above, voluntary Bureaux in Wales render a valuable service to the community, and the statistical data collated from the Returns submitted by 15 of these Bureaux give some indication of the volume and variety of enquiries dealt with during the year. The emergence of the Landlord and Tenant Act and the Housing and Repairs Act, has increased the number of enquiries under the "Housing" section.

The total number of enquiries dealt with by the Central and other Bureaux in Wales amounted to 24,855.

Social Welfare, Personal Service and Casework.—The emphasis on this service to the individual is confidence—and this special aspect of the Council's work cannot be assessed in terms of statistics. An upsurge in this work during

the year is shown by the many individual problems personally dealt with by the officer. Again, in the main these have a bearing on the effect of social changes on family life and can be attributed—*inter alia*—to housing difficulties; family relationships; matrimonial difficulties; maladjustment to environment; unemployment causing social unrest and disquietude; family budgeting, etc. Not always can we unravel all these personal problems, but with patient listening allied with sympathy and understanding, there is always the possibility of suggesting a means of relieving anxieties and personal tensions or directing the enquirer to the appropriate source of assistance.

Problems of the Physically Handicapped.—The Council in co-operation with the Central Council for the Care of Cripples arranged a Conference of delegates from interested Statutory and Voluntary Organisations. From this emerged a Working Committee which has since met and a further Conference will be called to discuss their findings.

Children.—Sponsorships under the aegis of The Save The Children Fund have been granted as a result of our recommendations. Home visits and reports have been made by our Officer.

Welfare of the Blind and Elderly.—Enquiries affecting elderly people and elderly blind persons have brought to our notice many of their problems. The following is an excerpt from a letter sent by the Chairman of Blind Centre :

"I am writing on behalf of the members of the Blind Centre to express their very great appreciation for the valuable assistance rendered in enabling them to have free chiropody treatment, etc."

Legal Aid and Advice.—Through their representation on the National Council's Standing Committee on Legal Aid and the co-operation of the Law Society's Area Secretary, the Council's Officers are keeping in touch with any developments at national and regional level.

General.—We have had visits and enquiries from University students and social workers at home and abroad. A tour of the City of Cardiff and, by courtesy of the Lord Mayor, a civic welcome were arranged for a party of Danish children who visited this country in June.

Arts Reproduction Loan Scheme.—The Arts Council has provided a new series of Reproduction Paintings which will shortly be available on loan to Community Centres and Adult Education Movements.

OLD PEOPLE'S WELFARE

There are now ten county co-ordinating Old People's Welfare Committees in Wales, and three County Borough Committees. During the current year a new County Committee was formed in Radnorshire; and at Swansea a new Committee representative of the many Statutory and Voluntary interests within the Borough is now organised for a wide range of planned activities for the local aged.

Substantial progress continues to be made in developing local Welfare Committees in Welsh urban and rural areas. Increasing encouragement in this direction has been forthcoming from Welsh District Councils, by their

implementation of the Ministry's circular 11/50, "The Welfare of the Aged," and by their putting into practical effect the helpful directives issued to them by the Welsh Board of Health.

The "Second Welsh Old People's Week," held in October, 1954, fully upheld the hope that it would achieve even greater success than did the original venture in 1953. Increasing co-operation on the part of local District Councils contributed to this in large measure, allied with the continued practical co-operation of the Welsh Board of Health and other Ministries, the B.B.C., the Churches and the Press. In consequence the Welsh Regional O.P.W.C. has decided upon establishing "Old People's Week" permanently as an annual feature of its work in the Principality.

The provision of club premises for the daily use of the old folk, continues to exercise the activities of many local committees throughout Wales. During 1954 completed club projects were officially opened at Hopkinstown (Pontypridd), Newbridge (Mon.), Tirphil, Ystalyfera and Maesteg (Glam.), and the foundation stone of a new building was laid at Newport (Mon.) by the Chairman of the Borough O.P.W.C. during Old People's Week.

The ambitious voluntary effort at Nelson will be completed by the Summer of 1955, as will several Club development projects in Monmouthshire and North Wales. Elsewhere throughout Wales, Welfare and Clubs Committees are negotiating for sites and collecting funds in order to proceed with similar projects in their localities.

Between 1949 and 1953, substantial grants for this work were obtained from the National Corporation for the Care of Old People, enabling 42 building projects to be completed.

In 1954 the King George VI Memorial Foundation inaugurated its "Old People's Club Development Scheme" whereby grants for Old People's building projects became possible under conditions somewhat similar to those laid down formerly by the National Corporation.

Full advantage of this scheme is being taken by this Council through its Old People's Welfare Department, in order that the maximum aid towards club buildings is obtained by local Welsh Committees. Up to March, 1955, successful applications have resulted in grant allocations to the following projects: Newport; Caerphilly; Holyhead; Nelson; Llanfoist; Rhymney; Tirphil; Aberdulais; Garw Valley; Ogmore Valley; Bargoed; Caerau; Bangor.

Some twelve further applications from Wales are in preparation for early submission to the appropriate London Committee, and another ten projects may possibly be sufficiently advanced to submit applications for grant aid before the Fund closes for an interim stock taking of its resources in June.

Organised visiting, chiropody services, clubs with their manifold social activities, entertainments and excursions, are all part of the voluntary service which is encompassed in the general conception of "Welfare of the Aged"; of which the then Minister of Housing and Local Government (Rt. Hon.

Harold Macmillan, M.P.) said at the last National Conference : " In youth is the Spring with its blossom and new life that appeals to us most, but as one grows old we begin to appreciate the deep beauty of Autumn tints and long shadows and peace and calm ; and if it should be our individual lot to live long beyond the Autumn into the Winter of life we should try to do what we can now to make the last stage not one of discontent, but one of cheerful and quiet happiness. So that old age may become a blessing as it should be ; for, after all, it is the portal of immortality."

THE STANDING CONFERENCE FOR WALES OF VOLUNTARY YOUTH ORGANISATIONS

This Conference for which the Council provides the Secretariat is a consultative and co-ordinating body, on which thirty Youth Organisations are represented. The Chairman is the Hon. J. H. Bruce.

The Conference meets at regular intervals to discuss problems affecting its constituent organisations, both on a national and a regional basis. It is recognised as a body to be consulted concerning the interests of youth, and is represented on the following bodies : The Council of Social Service for Wales and Monmouthshire ; the Central Council of Physical Recreation ; the Management Committee of the Rhondda Camp and Conference Centre, and through its constituent organisations, the County Youth Committee of some of the Welsh County Councils.

B.B.C. CHILDREN'S HOUR APPEAL FUND

One of the most rewarding of our activities is the administration and distribution of the fund allocated to Wales by the B.B.C. for the benefit of crippled and invalid children.

During the year under review, gifts to the value of £370 were made to 469 children.

We are grateful to all those who year after year assist in the distribution, and for their personal interest in the handicapped children.

THANKS

To the Ministries, Development Commissioners, Local Authorities, and Trusts, who, by their grants, make possible the maintenance and development of our work, we make grateful acknowledgement.

To the Social Service Clubs, Individuals, Industrial Concerns, Business Houses, and Trades Unions who have supported and encouraged us with donations and subscriptions, we offer our deepest thanks.

To the Coal Industry Social Welfare Organisation (South Western Division) for their very generous donation of £500, and for the opportunity afforded to us to co-operate with them in the provision of services to miners and their dependents.

To the Welsh Society, Kimberley, South Africa, for their much appreciated donation. May we hope that many other Welsh Societies both at home and abroad will follow their example.

OBITUARY

It is with deep sorrow that we record the death of our President, Captain Geoffrey Crawshay, D.L., LL.D.

When Sir Percy Watkins established a branch of the Council of Social Service in Cardiff in 1933, Geoffrey Crawshay was then immediately at hand, and when the Cardiff branch quietly developed into a South Wales Council of Social Service, he for the first year acted as honorary secretary to the new Council, until he was appointed to be its first Chairman. In those early and difficult days, Captain Geoffrey Crawshay proved a tower of strength to the new organisation.

His commanding presence, his ready good sense, cheerful friendliness, and his established contacts with industry, the Welsh Guards, the Welsh Rugby Union, the National Eisteddfod, and his political sympathies were all at the service of the Council in its incessant efforts to preserve human values, and to keep good things alive in those dark days in Wales. He was equally unremitting when the Council extended its scope to bring in North Wales in 1945, and he thus became the first Chairman of the Council of Social Service for Wales.

In 1949, the Council gladly seized the opportunity to make him President and his period of office, though lamentably brief, was fruitful and happy. It was a privilege at all times to work with him in any of his varied interests in Wales, and to know him was indeed a benediction.

Mr. W. P. Thomas's tenure of membership of the Council was all too short, but in that brief period he took a keen interest in all the activities of the Council.

It was with great sorrow that we learnt, on October 22nd, that our beloved colleague, Miss Betty Richards, had passed away suddenly the previous evening. Miss Richards had been on the staff of the Council for 19 years. She had suffered poor health for a number of years. She devoted herself wholeheartedly to her work, and her illness did not lessen her interest in all branches of the work of the Council. Her goodness and greatness of heart will always remain a warm and delightful memory to us all.

GWEITHGAREDDAU GWLEDIG

Dechreuwyd gweithredu polisi newydd Comisiynwyr Datblygu'r Ardaloedd Gwledig ar Galan Ebrill, 1954, a pheri cyfuno'n gyntaf peth waith Cynghorau Cymdeithas Wledig, a darparu cyflwyniadau i ddatblygu ymhellach.

O weithredu'r polisi newydd daw i'r Cyngor gyflwyniadau newydd a chyfrifoldeb newydd yn y gwaith o arolygu llafur Cynghorau Cymdeithas Wledig, ac yng ngwaith Adran Wledig y Cyngor ei hun.

Sefydloedd y Cyngor Bwyllgor Gwledig er mwyn cwrdd â'r amodau newydd, ac er mwyn gweithredu'n fwy esleithiol. Swydd y Pwyllgor yw astudio'r amodau yng Nghymru Wledig a gwneuthur arolygon lleol efallai o bryd i'w gilydd. Bydd ei ofal gan mwyaf yn:

(a) Gymdeithasol ac Adlonnol

Adeladu Neuaddau Pentrefi. Eu cynnal a'u defnyddio, a darparu Meysydd Chwarae.

(b) Diwydiannol

Astudio amrywiol ddulliau amaethu yng Nghymru. Arolwg ar Ddiwydiannau Gwledig, a chynnig awgrymiadau, os gellir, i'w datblygu, ac i gychwyn diwydiannau newydd, yn arbennig y cyfryw rai ag y sydd â pherthynas agos zhyngddynt ac Amaethyddiaeth a Choedwigaeth.

(c) Addysgol

Cerdoriaeth, Drama, Creftaith. Cefnogi ffurfio dosbarthiadau yn y pynciau hyn.

Bydd cysylltiad agos rhwng gwaith y Pwyllgor ac eiddo'r naw Pwyllgor Cymdeithas Wledig yng Nghymru, a dyrry adroddiadau cyfnodol, drwy swyddogion y Cyngor, ar y gweithgareddau hyn.

Ni sefydlwyd Cyngor Cymdeithas Wledig yn siroedd y Fflint, Maesyfed, Brycheiniog a Morgannwg. Ynddynt hwy y mae Adran Wledig y Cyngor yn gwneuthur gwaith y Cyngor Cymdeithas Wledig, a chyfeirio at y siroedd hyn yn unig y mae'r manylion canlynol.

NEUADDAU PENTREFI

Nodasom yn adroddiad y llynedd fod amodau grantiau'r Weinyddiaeth Addysg yn effeithio'n ddifrifol ar y datblygiadau mewn adeiladu. Eleni yr ydym yn llawen o allu cronio bod y sefyllfa'n well o lawer, ac felly y mae diodderdeb a gweithgarwch Pwyllgorau Neuaddau Pentrefi wedi adfywio'n rhyfeddol, fel y dengys y daflen hon :

MEYSYDD CHWARAE

Darparu'r Cyngor ysgrifenyddion ar gyfer pedair Cymdeithas Sir Meysydd Chwarae. Enynnodd hyn ddiddordeb mewn darparu Meysydd Chwarae, ac mewn rhoddi pob cyngor a chymorth posibl i Awdurdodau Lleol a Mudiadau Gwirfoddol gyda'u cynlluniau.

Bu Swyddog Gwlad y Cyngor yn helpu tri chynllun ar hugain, a chawsant hwythau, yn ystod y flwyddyn, gymorth ariannol gan Gymdeithas Genedlaethol Meysydd Chwarau. Y mae chiwe chynllun arall ar waith, ac yn amrywio ym mesur eu datblygiad. Cynnwys y cynnydd diddorol hwn Siroedd y Flint, Maesyfed, Brycheiniog a Morganwg.

At y pethau hyn y mae'r Cyngor yn annog Pwyllgorau Lleol y Pentrefi, sydd wedi eu ffurfio i godi Neuaddau, neu i drefnu Meysydd Chwarae, i ehangu eu gweithgarwch fel y bo'n cynnwys holl ddiddordebau bywyd y pentref, ac i ystyried lles yr holl bentref, ac i ddarparu'r cyfrwy bethau ag y mae awydd cyffredinol amdanant, ac y gellir eu sicrhau'n rhwyddach drwy gyd-yndrech. Y mae cyfuno diddordebau'r pentref fel hyn â'r Neuadd Bentref neu'r Maes Chwarae yn anhepgor os am gadw'r gymdeithas bentrefol yn fyw a grymus.

CYNGHORAU PLWYF

Y mae'n dda gweled bod dynion yn dechrau gwir sylweddoli bod gan y Cynghorau Plwyf eu cyfraniad i Lywodraeth Leol. Nid oes un problem a berthyn i bobl yr Ardaloedd Gwledig nas wynebwyd gan Gymdeithasau Sirol y Cynghorau Plwyf, a'u dwyn i sylw'r awdurdodau uwch gyda chryn lwyddiant yn aml. Trafodwyd illu o gwestiynau, a throes y trafodaethau'n weithredoedd. Ymhliith y cwestiynau hyn yr oedd cyfeleusterau Telefon, gwell ac amlach gwasanaethau teithio, cyflenwad dŵr, goleuadau, Meysydd Chwarae, a hawlau llwybrau. Rhoes y Gymdeithas Sir wasanaeth gwerthfawr arall, sef gwneuthur gwaith swyddfa hysbysu i'r Cynghorau Plwyf yn unigol, a'u cynghori ar eu hamrywiol broblemu.

Gweithgarwch pwysig arall yw propaganda ac addysg, ac y mae llawer Pwyllgor Cylch yn trefnu darlithoedd ac ysgolion ar weddau amrywiol Llywodraeth Leol.

Daeth Deddf y Parcua Cenedlaethol a Diogelu Hen Lwybrau i tym yn 1949. Gofynnwyd i bob Cyngor Sir yng Nghymru a Lloegr wneuthur arolwg ar hawliau Llywbrau, pob un yn ei radbarth ei hun, a pharatoi mapiau a mynegiadau. Yn ôl y Ddeddf gall y Cyngor Sir fwrrwr baich ar y Cynghorau Plwyf a'r Cynghorau Dosbarth. Dymunol yw deall bod Cynghorau Siroedd Cymru wedi gwahodd y cynghorau hyn i wneuthur y gwaith enfawr hwn. A da gennym gyhoeddi bod un ardddeg o dair sir ardddeg Cymru wedi ewblhau'r arolwg a'r mapiau a'r mynegiadau.

Y duedd heddiw ydyw canoli awdurdod, a threfnu unedau gweinyddol ehangach, eithr crys y Cyngor Plwyf yn gaer i ymdrechion lleol a gwirfoddol, a dyma uned democraeth gefn gwlad.

Y llynedd bu'r Cyngor ar ei eithaf yn cefnogi a datblygu'r Drama Amatur yn Nghymru. Cynhullodd y Cyngor, yn gynnar yn y flwyddyn, gynhadledd o gynrychiolwyr Pwyllgorau Drama Sir, Ysgrifenyddion Cynhorau Cymdeithasol Wledig, ac unigolion yn ymddiddori yn y ddrama amatur.

Eglurodd swyddigion y Cyngor mi amcan y cyfarfod oedd ffurfio Cymdeithas Drama ar gyfer Cymru gyfan. Dyry cyfansoddiad y Cyngor gymhwyster iddo sefydlu'r cyfryw Gymdeithas, a delio ar sylfaen genslaethol a' ddrama amatur. Penderfynodd y Gynhadledd yn unfrydol, ar ôl ymra-fodaeth, ffurfio Cyngor Drama i Gymru, a'i ganolfan i fod yn swyddfeydd Cyngor Gwasanaeth Cymdeithasol Cymru a Mynwy.

Prif amcanion y Cyngor Drama yw:

- (1) Hyrwyddo a threfnu cystadleuthau chwarae un-act yn Genedlaethol a Rhanbarthol.
- (2) Cefnogi ysgrifennu dramau yn Gymraeg a Saesneg.
- (3) Trefnu Ysgolion Drama.
- (4) Hyrwyddo trefniadau ar gyfer arholiad y Bwrdd Drama Amatur.

Y Llyfrgell Ddrama.—Y mae'r Cyngor yn darparu gwasanaeth cyflawn ar gyfer Cymru gyfan. Gall Cymdeithasau Amatur, a myfyrwyr Drama drwy'r Dywysogaeth feithysa o'i lyfrgell ddrama eang, sy'n cynnwys dros ddeng mil o gopiau o ddramau a gwerslyfrau. Y mae'r swyddog sy'n gofalu am y llyfrgell yn barod i roi cyfarwyddyd cymwys ar ddewis dramau. Aeth allan y llynedd 809 o setiau o chwaraeon, a 2,254 o gopiau unigol. Bu galw trwm am ein llenni llwyfan a'r offer goleuo. Aeth y llenni i 86 o Gymdeithasau Drama, a'r offer goleuo i 47.

Trefnodd Gwasanaeth Ymgynghorol y Cyngor ynglŷn â'r Ddrama i'w baner cyngorwyr wneuthur 92 o ymwiadau, a darlithio âr Gynhyrchu, Lleferydd, Meim, Ysmyriad, Trefnu'r Chwarsaewyr ar y Llwyfan, Dramau'r Ing, ac ar sut i Ffurfio Cwmni Drama.

Cynhaliwyd y llynedd chwech ysgol un-dydd, ac ysgol breswyl am wythnos. Bu llwyddiant mawr, a rhos y Athrawon air uchel i waith y myfyrwyt.

Trefnodd y Cyngor, am yr ail dro, mewn cydweithrediad â Chymdeithas Ddrama Morgannwg a Mynwy, gwrs o ddar�ithoedd ac arddangosiadau i baratoi myfyrwyr ar gyfer Arholiad y Bwrdd Drama Amatur. Eisteddodd deuddeg, ar ôl dilyn y cwrs, a llwyddodd pump i ennill "Diploma't Bwrdd Drama Amatur".

Ni all ffugrau moel roddi darlun cywir o ymdrechion gwirfoddol enfawr minteoedd o bobl i sicrhau cyfeusterau digonol yn eu hardaloedd ar gyfer gweithgareddau corfforol achymdeithaso lac addysgol. Ni ddug yr ymdrechion hyn firwyth y llynedd oherwydd y cyfngu ar gymorth ariannol ac ar adeiladu. Ar ddiwedd y flwyddyn penderfynodd y Llywodraeth laicô'r cyfyngiadau, a daeth gobal newydd a symboliad newydd i lu o ymgymriadau. Dywedir y caiff cynlluniau sy'n galw am frys sylw buan a chymorth ariannol, ond credwn oll fod anghenion ein hardal ni yn fwy nag eiddo mannau eraill. Y mae Undebau Cymdeithasol sydd heb adeiladau, ym mhobman yn paratoi eu cynlluniau; ac os methwn a llwyddo, bawb, er hynny y mae'n bwysig ein bod oll yn cyflwyno'n cynlluniau, fel y gwypô'r Weinyyddiaeth Addysg faint ein gofyn.

Pery'r ystadau tai newyddion i gael y sylw cyntaf, am nifer o resymau da. Y mae dau bwynt amlwg yn y cyswilt hwn yn galw am ystyriaeth : (1) Lle y bwriedir codi Canolfan drwy lafur gwirfoddol, ac felly ennill-hawl i gymorth

aciannol uwch, y mae cynllunio a threfnu'r llafur yn ofalus yn anhepgor, neu fe all y gwaith sefyll cyn ei orffen. Digwyddodd hyn eisoes yn un lle, ac anodd yw aifgynnau'r diddordeb sy'n rhaid wrtho i orffen y gwaith. Rhwng 1954 a lawer iawn yw tybied y gellir creu ysbyrdd cymdeithas heb wneuthur dim mwy na chasglu pobl yn finteoedd mawrion ar achlysuron cymdeithasol. SWYDDFEYDD CYNGHORI DINASYDDION A'U LLES CYMDEITHASOL

Y mae'r Cyngor yn darparu, yn ei swyddfa ei hunan, wasanaeth hysbysu a chynggori. Daeth llawer mwy o bobl i wybod am y gwasanaeth hwn rhwng Hydref 1954 a Mawrth 1955, a chynyddodd rhif ac amrywiaeth y problemau, a'r ymholaidiad u bu'r Swyddog yn delio â hwy. Ceisir ein help drwy lythyr a'r telefon o bob rhan o'r wlad ac o'r tu hwnt i'r môr. Yr ydym wedi gofalu, hyd eithaf ein gallu, fod pob un a fu'n holi am gymorth neu gyngor yn bersonol neu fel arall, wedi cael yr help angenrheidiol, neu wedi ei gyfarwyddo i'r man y gall ei gael.

Y mae hefyd yn aelod o Bwylgor Swyddfeydd Cenedlaethol Cyngori Dinasyddion. Cedwir cyswilt agos felly a'r gwasanaethau yn eu pris swyddfeydd.

Y mae cydweithrediad effeithiol rhwng yr adran a Chyrrif Cyfreithiol a Gwirfoddol.

Adroddiad ar y Sefyllfa.—Ar wahân i'r Gwasanaeth Canolog y cyfeirir ato uchod, dyry Swyddfeydd Gwirfoddol yng Nghymru wasanaeth gwerthfawr i gymdeithas, a gwelwn swm ac amrywiaeth yr ymholaidiad u deliwyd â hwynt y llynedd oddi wrth y ffugrau a gasglwyd o Adroddiadau pymtheg o'r Swyddfeydd hyn. Gyda dyfod i rym Ddeddf y Landlord a'r Tenant, a Ddeddf Tai ac Atgyweirio, chwyddodd rhif yr ymholaidiad o dan adran "Tai".

Deliodd y Swyddfa Ganol a Swyddfeydd eraill yng Nghymru â 24,855 o ymholaidiadu.

Lles Cymdeithasol. Gwasanaeth i'r Unigol.—Ymddiriedaeth yw hanfod gwasanaeth i'r unigol, ac ni all ffugrau ddangos gwerth y wedd hon at waith y Cyngor. Dengys y llu problemau unigol, y deliodd y Swyddog yn bersonol â hwy yn ystod y fwyddyn, gynnydd eithriadol yn y gwaith hwn.

Y mae a wnelo'r rhain, gan mwyaf, ag effaith y cyfnewidiadau cymdeithasol ar fywyd y teulu, a gellir eu priodoli—ymhlith achosion eraill—i brinder tai cymwys, y berthynas deuluaidd, anawsterau priodasol, anghytgord a'r amgylchedd, diweithdria yn peri anniddigrywedd a chynnwrf, a threfnu cyllideb y teulu. Nid bob amser y medrwn ni ddatrys yr holl broblemau personol hyn: eto, o wrando'n amyneddgar, gyda chydymdeimlad a deall, gellir o leiaf awgrymu moddion i ysgafnha'u'r pryderon a'r beichiau personal, neu gyfarwyddo'r ymholydd at ffynhonell cymorth addas.

Cymorth a Chyngor Cyfreithiol.—Drwy eu cynrychiolaeth ar Bwyllgor Sefydlog y Cyngor Cenedlaethol ar Gymorth Cyfreithiol, a chyd-weithrediad Ysgrifennydd Rhanbarth Cymdeithas y Gyfraith, y mae Swyddogion y Cyngor yn gwyliau'n fanwl bob datblygiad cenedlaethol a rhanbarthol.

Cyffredinol.—Bu myfyrwyr Prifysgolion a gweithwyr cymdeithasol gartref a thrwmor yn ymweled â ni, ac yn gwneuthur ymholaiedau. Ymwelodd parti o blant Denmarc & Chymru ym Mchefin. Trwy gwreisi'r Aргlwydd Faer, cawsant groeso dinesig, a threfnwyd iddynt daith drwy'r ddinas.

Cynllun Rhoi Benthyg copiau o Baentiadau.—Darparodd Cyngor y Celfyddydau gyfres newydd o gopiau o baentiadau, ac ar fyr dro gellir eu benthyca gan Ganolfannau Cymdeithasol a Mudiadau Addysg Oedogion.

LLES HEN BOBL

Y mae yng Nghymru heddiw ddeg Pwyllgor Sir Lles Hen Bobl, a thrif Phwyllgor Bwrdeisdref Sirol. Pfurfiwyd Pwyllgor Sir newydd eleni yn Sir Faesyfed; ac y mae un arall newydd yn Abertawe yn gweithredu cynlluniau eang ar gyfer ei hen bobl, a chynrychiolir arno fudiadau Cyfreithiol a Gwirfoddol sy'n ymddiddori yn yr Hen Bobl o fewn y Fwrdeisdref.

Pery cynydd sylweddol yn natblygiad Pwyllgorau Lles lleol mewn cylch-oedd dinesig a gwledig yng Nghymru. Rhoes Cyngorau Dosbarth fwy o gefnogaeth nag o'r blaen drwy weithredu Cylch-lythyr y Weinyddiaeth 11/50 "Lles yr Hen Bobl", a thrwy ddilyn yn ymarferol gyfarwyddiadau buddiol Bwrdd Iechyd Cymru iddynt.

Ni siomwyd ein gobaith y byddai "Ail Wythnos Hen Bobl Cymru" yn Hydref 1954 yn fwy llwyddiannau hyd yn oed na'r antur gyntaf yn 1953. Am fesur helaeth o'r llwyddiant hwn cydnabyddwn gyd-weithrediad cynyddol y Cynghorau Dosbarth lleol, a chyd-weithrediad ymarferol cyson Bwrdd Iechyd Cymru, a Gweinyddiaethau eraill, a'r B.B.C., a'r Eglwys, a'r Wasg. Oherwydd hyn penderfynodd Pwyllgor Lles Hen Bobl Cymru sefydlu "Wythnos yr Hen Bobl" yn than o'i waith yn y Dywysogaeth.

Y mae amryw bwylgorau lleol drwy Gymru wedi bod yn ddyfal yn darparu adeiladsu fel y gallo'r oedrannus eu defnyddio'n feunyddiol. Yn 1954 gorffennwyd clybiau a'u hagor yn swyddogol yn Nhrechopcyn (Pontypridd), Pontnewydd (Mynwy), Tirffil, Ystalyfera, a Maesteg (Morg.); a gosodwyd carreg sylfaen adeilad newydd yng Nghastellnewydd (Mynwy) gan Gadeirydd Pwyllgor Lles Hen Bobl Cymru yn y Fwrdeisdref yn ystod Wythnos yr Hen Bobl.

Bydd ymdrech wifoddol uchelgeisiol Nelson wedi cyrraedd ei nod erbyn haf 1955, yn ogystal ag amryw ymgymriadau datblygu yn Sir Fynwy a'r Gogledd. Y mae Pwyllgorau Lles a Chlybiau mewn mannau eraill yng Nghymru yn ceisio trefnu cytundebau ar safleoedd adeiladu, ac yn casglu cronfeydd i fynd ymlaen ag ymgymriadau cyffelyb yn eu hardaloedd hwy.

Rhwng 1949 ac 1953 cyfrannodd Corfforaeth Genedlaethol Gofal am Hen Bobl gymorth ariannol sylwedol at y gwaith hwn, a gorffennwyd dau adeilad a deugain.

Yn 1954 cychwynnodd Sefydliad Coffa'r Brenin Siôr VI ei "Gynllun Datblygu Clybiau Hen Bobl", a rhoddi gymorth ariannol i godi adeiladau i'r Oedrannus ar amodau rywbeth yn gysfelyb i eiddo'r Gorfforaeth Genedlaethol.

Manteisia'r Cyngor yn llawn ar y cynllun hwn drwy ein Hidran Les Hen Bobl fel y gallo Pwyllgorau Lleol Cymru sicrhau'r cymoeth mwyaf posibl at adeiladu clybiau. Hyd at Fis Mawrth 1955 llwyddodd ceisiadau am gymorth o'r lleoedd canlynol: Casnewydd, Caerfili, Caergybi, Nelson, Llanfoist, Rhymni, Tirffil, Aberdulais, Cwm Garw, Cwm Ogwr, Bargoed, Caerau a Bangor.

Y mae rhyw ddeuddeg cais ychwanegol yn cael eu paratoi yng Nghymru i'w cyflwyno'n fuan i'r Pwyllgor priodol yn Llundain; ac o bosibl y bydd deg ymgymriadau arall yn ddigon aeddfed fel y gellir danfon ceisiadau am gymorth cyn i'r Gronfa gau dros dro ym Mehefin i gymryd stoc o'i hadnoddau.

Beth yw syniad cyffredinol yr ymadrodd "Lles Hen Bobl -" Y mae'r holl bethau canlynol yn rhan o'r gwasanaeth gwifoddol sy'n gynwysedig ynddo: trefnau ymwelladau, triniaeth i'r traed, amrywiol weithgareddau cymdeithasol clybiau, adloniant, a gwib-deithiau. Wrth ddelio â'r gwaith yn y Gynhadledd Genedlaethol ddiwethaf dywedodd y Gwir Auriydeddus Harold Macmillan, A.S., ac yntau ar y pryd yn Weinidog Tai a Llywodraeth Leol: "Gwanwyn a'i flagur a'i fywyd newydd sy'n apelio fwyaf atom yn ein hieuencnid, eithr fel yr heneiddiwn, dechreuwn werthfawrogi prydferthwch dwys yr Hydref a'i liwiau a'i gysgodion hir a'i dawelwch a'i dangefedd, ac os daw i ran neb ohonom gyrraedd gaeaf bywyd, dylem yn awr wneuthur a allom fel na bo rhan ola'n tuith yn dymor o anfodlonrwydd, eithr yn hytrach yn dymor o sirioldeb a llawenydd tawel. Felly y bydd henoed yn fenthith, fel y dylai fod; canys yn wir dyma borth anfarwoldeb."

Rhœs y cwbl a feddai yng ngwasanaeth y Cyngor, ei bersonoliaeth urddasol, ei ddoethineb, ei gyfeillgarwch llawen, ei gysylltiadau agos â diwydiant, â'r Gwarchodlu Cymreig, ac Undeb Rugby Cymru, ac â'r Eisteddfod Genedlaethol, a'i duddiadau gwleidyddol.
